Dear Delegate Campbell,

My name is Vickie Rogers and I am a Registered Nurse. I reside in Wythe County,
Virginia. I am contacting you concerning Bill SB 1083. This bill would require meningococcal
vaccinations to be added to the recommended immunizations for school aged children.

Meningitis is a contagious illness that affects the covering of the brain and spinal cord. There are
approximately 1000-1200 cases of meningitis every year. Even with treatment, the effects of
meningitis can be death, loss of arms or legs, nervous system problems, deafness, and seizures or
strokes ("Meningococcal VIS," 2011). We can protect the health of our children and community
by adding the meningococcal vaccine to the recommended childhood immunizations.

I am aware there are those that oppose immunization and are concerned about their safety (ProCon.org website, 2015). Immunizations are recommended to ensure the well-being and safety of society. Immunizations have effectively reduced or eliminated many childhood diseases such as smallpox, polio, and measles. A large number of hospitalizations, illnesses, disabilities, and deaths are prevented each year due to the required immunizations children receive (Whitney, Zhou, Singleton, & Schuchat, 2014). Immunization does not only provide protection for the individual but also for everyone that may come in contact with them

("Vaccinations," 2014). A recent example of how easily disease can be spread is the measles

outbreak linked to a visitor to Disney World. Over 173 cases of measles were reported and

experts cited under immunization, or lack of immunization, as being responsible for the outbreak

(Zipprich et al., 2015).

Vaccines are vigorously tested prior to approval by the Food and Drug Administration

(FDA) and continue to be monitored when in use for any possible side effects ("Vaccine Safety,"

2011). The safety of vaccinations has been proven by the large number of administrations and

the small number of complications (Epling, Savoy, Temte, Schoof, & Campos-Outcalt, 2014).

The risk of being vaccinated far outweighs the risk of complications from contracting the

disease.

I ask that you support Bill SB 1083. Your support will ensure the safety and well-being

of the public by ensuring children are vaccinated against a communicable disease that is

potentially fatal or may have a deleterious effect on their future well-being. It will also have a

positive effect on long term health care expenditure for ongoing treatment due to complications

or providing resources to contain an outbreak. Lastly, consider the words of Ben Franklin, "An

ounce of prevention is worth a pound of cure." Please feel free to contact me should you have
